MRSS Announces Standalone Un-Audited Results for H1 2017-18

Mumbai, November 13, 2017

BSE SME listed Majestic Research Services and Solutions Ltd has reported a standalone net profit of Rs. 4.51 crore for the half year ended September 30, 2017. The results are also available on <http://www.mrssindia.com>.

Income from operations for the half year ended September 30, 2017 grew to Rs. 20.04 crore as compared to Rs. 22.90 crore in the previous whole year 2016-17 and Earnings before interest, tax and depreciation (EBITDA) margin grew to 36% for the half year ended September 30, 2017.

The Board of the directors of the company had declared maiden interim dividend of Rs. 0.50/- per Equity share of Rs. 10/- each and also decided to initiate the process for migration of Equity Shares of MRSS from BSE SME platform to BSE Main Board platform.
